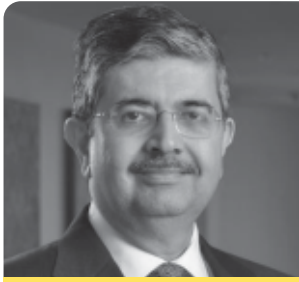
B-School Selection Process

Most B-Schools have a 2 stage selection process

- Aptitude Test – is generally the first stage of the B-School selection process CMAT, NMAT, SNAP, MAT, ATMA, TISS etc. are some prominent aptitude tests. Students are short listed for GD-WAT-PI based on their scores in the aptitude test and in certain tests, GD/PI forms a component of the overall score.
- GD-WAT-PI Group Tasks – is generally the second stage of the selection process. A student needs to do well in all or some of these activities if he wishes to get a high overall score which translates into a final call from the institute of his choice.

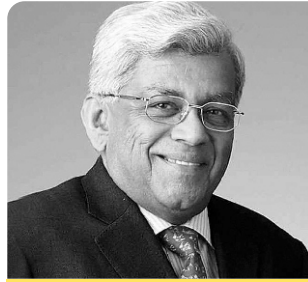

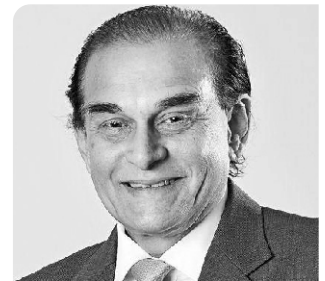

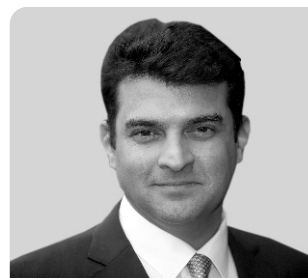

Understanding CET

MH-CET or MAH-MBA/MMS-CET as officially called is the state level entrance test for admission to MBA / MMS programs affiliated to Maharashtra university. The test followed by the admission process is conducted by the Directorate of Technical Education (DTE). CET is the gateway to esteemed Top college like JBIMS, SIMSREE and PUMBA. Many private colleges in Maharashtra also accept CET scores for their PGDM programs. Welingkar is one such notable college.

Admission to 85% seats in MMS / MBA colleges in MH is done through the CET and is reserved for Maharashtra students. The remaining 15% seats are All India seats to which a student can also apply to with his CAT, CMAT, XAT, MAT, ATMA or GMAT scores.

Eligibility Criteria

Graduate with a minimum 50% marks in aggregate or equivalent CGPA from a recognized university. The percentage requirement is relaxed to 45% in case of candidates of backward class categories and persons with disability belonging to Maharashtra State only.

Test Structure

The Test consists of 200 Multiple choice questions that assess different areas.

Mode: CET is a computer based test (CBT)

Duration: 150 minutes (2 ½ hrs).

Marking scheme: There is no negative marking for incorrect answers. Therefore, it is imperative that the students attempt all the questions and intelligently guess the answers to unsolved questions. Every correct answer fetches 1 mark. Incorrect or non-attempted question fetch zero marks. Therefore, the test is out of 200.

Admission Process

Since 2014, the admissions have been on the basis of CET scores for MH seats and other test scores for All India seats. GD-PI is not being conducted by DTE for CAP. Students should prepare for GD – PI if they are applying to PGDM programs using their CET score.

All About NMAT

The NMAT by GMAC is a computer-delivered entrance examination whose scores are accepted by 23 Bschoools in India, 7 Bschoools in SA and 3 Bschoools in Philippines. The test gives each candidate a randomly generated test from a pool of questions, delivered one-at-a-time. NMAT by GMAC can be taken thrice and the best of the scores shall be considered provided the candidate has applied to the institute with each of the scores.

NMIMS School of Business Management is the key bschool accepting NMAT and it offers 2 year Full Time MBA at Mumbai campus and PGDM at Bengaluru, Hyderabad, Indore and Navi Mumbai campuses.

All About TISS-NET

Tata Institute of Social Sciences, established in 1936, offers highly competitive, socially relevant Full-Time Post-Graduate Degree Programmes (M.A. / M.Sc. / M.P.H./ M.H.A.) in inter and trans-disciplinary areas of social work, health, management, development, habitat and climate sciences.

Admissions to all these programs are through TISS-NET followed by Pre Interview Test (PIT) and Personal Interview (PI). The objective test has questions related to Knowledge on Contemporary issues; Analytical Ability, Logical Reasoning; and General Knowledge. Only shortlisted candidates are called for the PIT / PI. The PIT consists of either a Group Discussion (GD) or a Written Test.
